Member Release, Agreement and Assumption of the Risk

In consideration of being allowed to participate as a member of the Arizona Dragon Boat Association, I agree to release, indemnify, and forever discharge the AZDBA, its agents, board members, officers, participants, employees and any and all other persons or entities acting in any capacity (hereinafter collectively referred to as "the AZDBA") on behalf of myself, my heirs, spouse, parents, estate, executors, administrators, assigns, personal representative as follows:

1. I agree that I am 14 years of age or older and my participation in dragon boating and/or other AZDBA activities encompasses known and unknown risks that could result in injury, loss, damage and death to myself, my property or to third parties.
2. I expressly agree and promise to accept and assume all of the risks, known or unknown, as a participant in dragon boating and other AZDBA activities. My participation in these activities is voluntary and I elect to participate despite the risks. I further agree to assume the risk(s) of any medical or physical condition that I may have.
3. I agree that participation in dragon boating and/or other AZDBA activities will be according to the guidance, instruction and/or rules of the AZDBA including wearing a personal flotation device (PFD) whenever I am on the water.
4. I agree that I also will use AZDBA dragon boats, paddles, PFD's and any other equipment provided or borrowed from the AZDBA at my own risk. I expressly acknowledge and agree that the AZDBA shall not be liable for any injury, loss, damage or death resulting from the use or suitability of said equipment.
5. I hereby voluntarily release, indemnify, hold harmless and forever discharge the AZDBA from all liability, actions, claims, demands from myself, my heirs, spouse, parents, estate, executors, administrators, assigns, personal representative for any loss, injury, damage, or death resulting from my participation in dragon boating and/or other AZDBA activities and the use of any equipment.
6. I understand that at any AZDBA activity, I may be photographed by the AZDBA. I agree to allow my photo, video or film likeness and reproduction thereof made through any media to become the property of the AZDBA and used for any legitimate purpose by the AZDBA.
7. I agree that this Release, Agreement and Assumption of the Risk are governed by the laws of Arizona. If any part of this Release, Agreement and Assumption of the Risk is deemed void or unenforceable, the remaining portions shall remain in full force and effect.
8. I am competent to sign this Release, Agreement and Assumption of the Risk.
